July 7th, 1985: David Timothy Crowley was born in Owatonna, Minnesota.

November 20th, 1986: Komel Rasool Alam was born at a U.S. Military Base in Riyadh, Saudi Arabia.

1998: The Alam family moved from Saudi Arabia to Pakistan to be closer to family.

2000: David befriended Mitch Heil in high school.

April/May 2003: David told his family he was enlisting in the U.S. Army upon graduation from high school.

June 23rd, 2004: David began Basic Training at Fort Benning, Georgia.

- *Possibly attached to 1st Battalion - 6th Infantry Regiment (The "Regulars") in Baumholder, Germany.*

2005: The Alam family moved from Pakistan to Richardson, Texas.
Daniel Crowley Sr. and Kate Crowley got divorced.

Early 2006: David was deployed to Iraq.

July 5th, 2006: The Alam family moved to Hewitt, Texas.

November 11th, 2006: David was transferred to Fort Hood, Texas.

Before October 22nd, 2008: David met Komel Alam in a bar in Waco, Texas. Six weeks after meeting, David and Komel got married.

Between October 22nd – November 5th, 2008: Komel Crowley became pregnant.

Early 2009: Komel received the “Rising Young Professional Award” from Baylor University.

June 23rd, 2009: David was discharged from the U.S. Army after serving a total of 39.5 months on foreign soil.

July 25th, 2009: Komel purchased a Springfield Armory XD .40 handgun from The Gun Zone in Dallas, Texas.

August 6th, 2009: Raniya Crowley was born.

Between August 6th - September 18th, 2009: The Crowley family moved to Minneapolis, Minnesota.

September 18th, 2009: Anjum Alam created an AT&T cell phone account for David.

November 8th, 2009: David and Komel both completed their "Permit to Carry" class.

January 7th, 2010: *Hothead Productions, LLC* was created.

Between January 7th – April 13th, 2010: David met Danny August Mason (DAM)

April 13th, 2010: David filed a form with the ATF which acknowledged he was building a customized short rifle AR-15 to be used as a movie prop.

April 21st, 2010: ATF approved David's AR-15 movie prop filing.

Between April 21st – May 1st, 2010: David began writing the first script for *The Gray State*.

May 1st, 2010: Officer Joe Bergeron, David's uncle and Kate Crowley's brother, was shot and killed in the line of duty in Minnesota.

September 17th, 2010: David transferred ownership of his AR-15 rifle to Adam Shambour in the form of a gift.

May 17th, 2011: The Alam family sold their Hewitt, Texas home.

Mid to Late 2011: David, DAM, and Mitch filmed scenes for *The Gray State* concept trailer.

August 10th, 2011: David transferred ownership of his Beretta handgun as a gift to DAM.

August 7th, 2012: *The Gray State* concept trailer was published on YouTube.

October 31st, 2012: Komel received her Master's Degree in Public Health Nutrition from the University of Minnesota. The Alam family arrived from Texas to celebrate.

Late 2012: David sold a Springfield XD .40 handgun (*refer to July 25th, 2009*) to David Stark.

June 2013: Writing professional, Linda Seger (Colorado), reviewed the script for *The Gray State*.

December 2013: The Crowley family moved into 1051 Ramsdell Drive in Apple Valley, Minnesota.

March 16th, 2014: Allison Crowley, David's sister, got engaged to Suzanne Gold.

April 13th, 2014: According to the New Yorker article, "Death of a Dystopian" by Alex Wilkinson, David began a journal on April 16th, 2014; however, the first journal entry was written on April 13th, 2014.

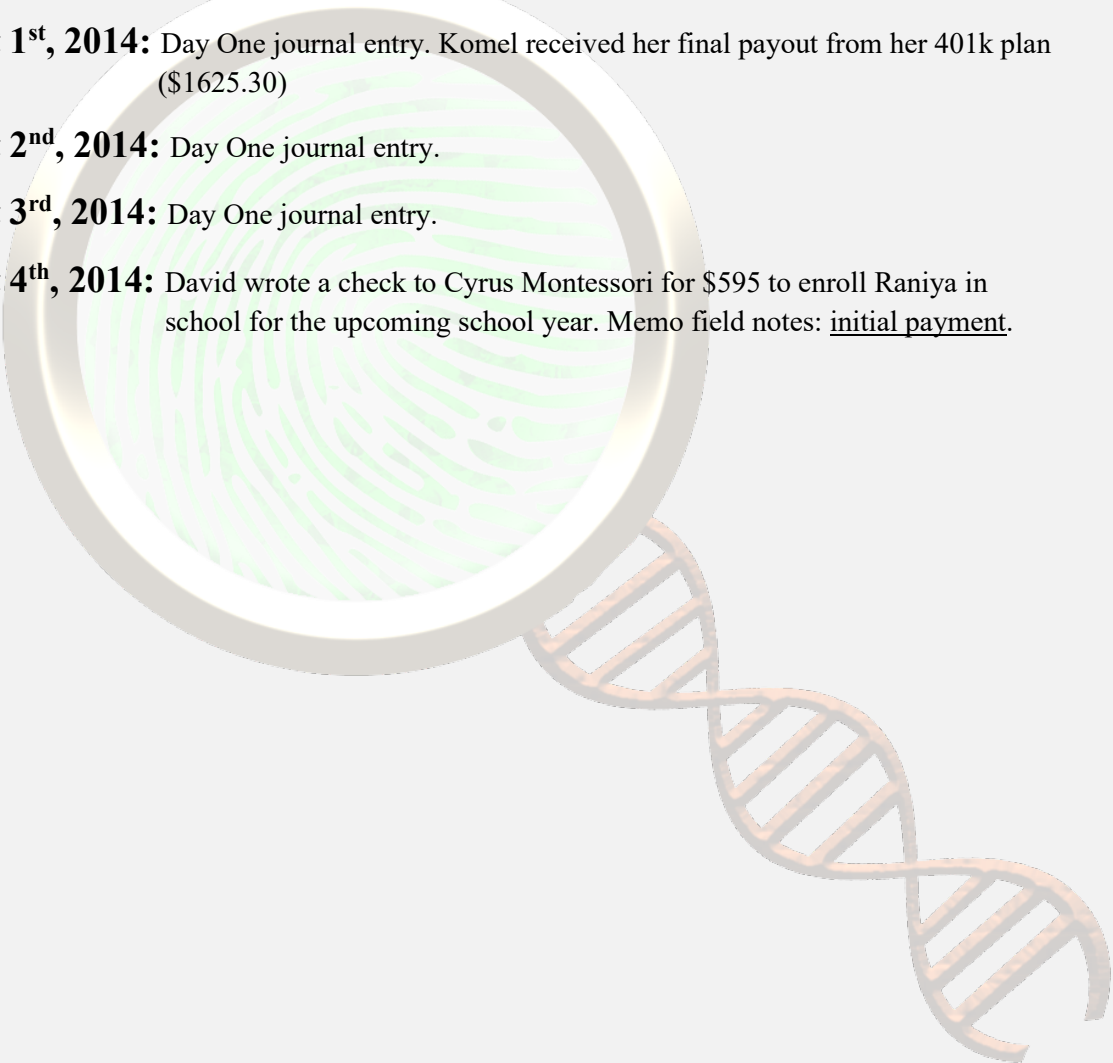

September 26th, 2014: Day One journal entry. Komel's last Instagram post and David heard back from MEG. They believed the script would work better as a TV Series **(DATE NOT CONFIRMED)**.

September 30th, 2014: Two (2) Day One journal entries. **9:35 AM:** David posted on Facebook that he was looking to “reinvigorate the film process by building a new, trustworthy team” (This post was deleted in late January 2015 by an unknown person). David posted on Facebook about the possibility of a Gray State movie, documentary and series. David answered *The Gray State* fans’ questions.

October 1st, 2014: Komel texted her sister Sidrah, "Happy Birthday!" (first response to Sidrah from Komel since August). David Crowley began the legal process to remove DAM from the project. David's attorney sent paperwork detailing this to DAM, but he never responded. David Crowley's last Instagram post.

October 4th, 2014: Day One journal entry.

October 5th, 2014: Two (2) Day One journal entries. David made a strange comparison between

October 12th, 2014: David allegedly called Anjum on the phone and “cussed him out.” Sidrah claimed her father "was upset and he cried."

October 15th, 2014: Plans were made within the Alam family to retrieve the Acura car that Anjum loaned to the Crowley family and exchange it with the Toyota Corolla that the Crowley family left with the Alam family.

October 16th or 17th, 2014: Sidrah and, her then-fiancé, Vinny, began the 17-hour drive from Texas to Minnesota in the Toyota Corolla. Anjum paid for meals and fuel. She texted Komel to say she was on her way.

October 17th, 2014: Day One journal entry. Joseph Seaton was negatively mentioned.

Beyond that got a text from joe - “we made beautiful music together. Goodbye Dave.” This pigeon head is butt hurt I haven't responded to his texts. He's a single asshole living alone with no job family or possessions. What does he imagine we have in common?

October 18th, 2014: Day One journal entry. A person named “Daniel J Crowley” withdrew **\$50,000 in cash** at a branch bank location from Dan Sr.’s Payable on Death (P.O.D.) account and signs their name as “Daniel T Crowley.” This account listed his three children (Dan Jr., Allison, and David Crowley) as beneficiaries to receive the contents upon his death. Additionally, there is nothing to support what this money was used for. **Around 12:00 PM:** Sidrah and Vinny arrived in Bloomington, Minnesota after driving through the night. They stopped at a mall parking lot to call and text Komel to announce their arrival and received no response. They spent some time shopping, then Sidrah drove 10 minutes south to Apple Valley. After receiving no response from Komel, she decided to ask the police department for advice. Sidrah worried that if she showed up at the home, David might call the police to announce a trespasser on the property which she wanted to avoid. Sidrah requested a dispatcher to call Komel directly to which they received no answer from Komel. **7:00 PM:** Sidrah and Vinny arrived at the Crowley residence and were turned away by David at the front door. Sidrah said that he wouldn’t allow her to see Komel or Raniya and was “rude.” Sidrah told David that she loved the Crowley family, but didn’t know what she did to deserve what happened. She explained that if there was something, she offered to apologize and fix it. Vinny talked to David and made some headway about switching cars. David agreed to let them drive the Acura back to Texas, but told them to "come back in one hour, as he had to clean it up" to which they waited an hour in a convenient store parking lot, before returning to the Crowley residence. **8:30 PM:** Sidrah exchanged cars and then drove off in the Acura toward Texas. Sidrah felt something wasn’t right about the vehicle and thought David may have tampered with it; so, they pulled into a nearby parking lot and called the police to request a K-9 unit to sniff around the car. The AVPD received the call from dispatch and denied the request. Sidrah called Anjum and he suggested they “spend the night at a local hotel, get some rest, and leave in the morning.” While driving to the hotel, Sidrah allegedly found a photograph of Naila, Sidrah, and Komel together during “happier times” and assumed that Komel placed it in the car since there was a note in Komel’s handwriting that read, "I always have and always will love you and mom" on the back. Sidrah and Vinny arrived at the Motel 6 in Albert Lea, Minnesota after driving 80 miles.

October 19th, 2014: Day One journal entry. Discussed his view of the “Christian root problem” and referenced the Christian Rock band, *Sanctus Real*. Sidrah and Vinny checked

Dan Jr posted a comment on his Facebook wall about “how easy it is to watch gruesome deaths on television” (This post was later removed). Komel posted her final entry on her business Facebook page. Komel tweeted for the final time. David’s last post on his personal Facebook page.

October 25th, 2014: Day One journal entry. This is also the last date in the journal that he stopped sharing his location.

October 27th, 2014: David contacted David Kirk West on Facebook and asked if he would like to produce the web-series scenes that would’ve been filmed in the Pacific Northwest.

October 28th, 2014: The State of Minnesota issued the Automobile Title Certificate for a 2005 Toyota Corolla in the name of Komel Crowley. Anjum shutdown the AT&T cell phone and data plan for David.

October 29th, 2014: David updated the cover photo on his personal Facebook page. Komel's last phone call on her AT&T line and it was to her mother. David’s last tweet.

October 30th, 2014: Three (3) Day One journal entries. Komel was hallucinating and David

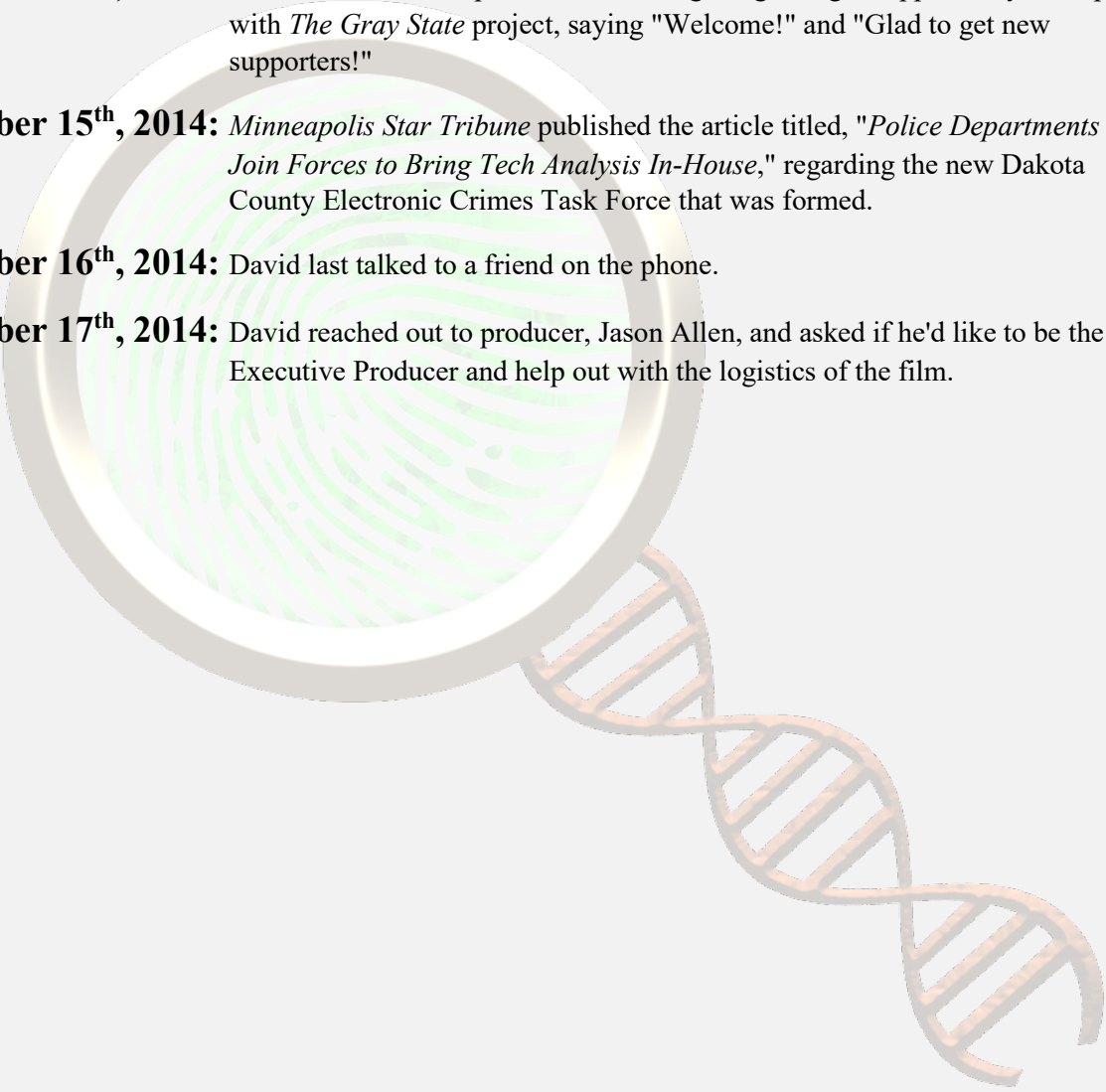

Det. Bone and McKnight met with the Crowley family in Owatonna, MN. They spoke with Dan Sr, Dan Jr, and Allison. **12:51 PM:** a 911 call to police by Judy Prochnow for "suspicious activity" at Crowley home. They saw a GMC truck with Army Paint on it (presumably Chris Klein's). Det. Booth contacted Christopher Peck. Det. Booth contacted DAM and DAM went out of his way to tell Booth that he had no role in the film other than as an actor and friend and that he was not connected from a business standpoint (**this statement is not true**). Chris Klein, Dan Sr, Dan Jr, Mason Hendricks, and Adam Shambour saw a hole in the ceiling near the residence's entry way.

The *Hagmann & Hagmann* internet radio show had interviewed David several times in the past for updates on *The Gray State* project. **Around 3:00 PM:** Mike Paczenzy published the "Rough Cut" of *The Gray State: The Rise* on YouTube (still contained Sean Wright's "tax stuff") 2 hr 39 minute version. **3:16 PM:** the online activist group, Anonymous, made a post on their Facebook page, provided a link to Lapp's Facebook page, and created the hashtag, #JusticeForCrowleys. **3:20 PM:** Lapp got in contact with the Gray State team. Lapp contacted Hennen to ask if he could make time for a conference call. **3:50 PM:** Lapp contacted Hennen to ask if 10:00 PM EST would work for a "GoToMeeting" online and mentioned that he spoke with Sean Wright. Wright expressed concerns to Lapp that Hennen's Facebook group had an invite to include James Fetzer to the group. Wright wanted Fetzer banned from the page. Hennen explained to Lapp that he invited Fetzer because he was a local. **4:20 PM:** Lapp communicated to Hennen that Hagmann was also interested in joining the conference call, but requested to move it out by one hour so it could be featured on the live *Hagmann & Hagmann show*. **Around 4:30pm:** Wright requested "admin" privileges on Lapp's "Justice" page and it was granted by Lapp. **5:00 PM:** members of the Gray State team were made aware of the "Rough Cut" video on YouTube that Paczenzy published without approval of the team. **5:39 PM:** Lapp informed Hennen, the Gray State team was in contact with YouTube to pull down the "Rough Cut" video and the team believed Paczenzy "went rogue" and confirmed the time for the live airing of the *Hagann & Hagmann show* will indeed be 11:00 AM EST. **5:55 PM:** DAM requested "admin" privileges on Lapp's "Justice" page. **Around 7:00 PM:** users noticed large amounts of info had been deleted from Lapp's "Justice" page and Lapp confirmed he didn't remove anything. **7:23 PM:** Brendan Jay's sister, Carissa, used the Twitter hashtag, #JusticeForCrowleys. **8:49 PM:** Lapp contacted Hennen to say the conference call had been cancelled and mentioned that things "got weird" in the past couple hours. Mr. Lapp stated that Wright demanded "full admin" privileges to Lapp's "Justice" page and would terminate the page if his demands weren't met. Lapp also mentioned to Hennen that Wright wanted to get "admin" privileges to Hennen's "Justice" page as well. Lapp said Wright repeatedly used the phrase, "Just give me full access ASAP."

January 21st, 2015: Hendricks made a post on Facebook saying "[they were] going to the home on Thursday (1/22) after the living room [was] cleaned to help make sense of the note." Hendricks published the "smiling guys" photo on his Instagram account. Posted on Hendricks account, "masonnorskhest," with the hashtag #brothers and purportedly taken after the TV interviews. Wright posted the same image on his personal Facebook account. A friend left a comment to Wright about an upcoming get-together and informed Wright, "no women allowed, Sharia law."

Youtuber, "TruthMediaRevolution," captured the screen shots of the posts that were deleted. He posted two videos that showed evidence of posts deleted. Doug Hagmann's article, "*Filmmaker David Crowley Dead in Murder-Suicide Confided 'I'm Not Prone to Suicide'*," was published in the Canada Free Press. Wright began a campaign to gain "admin" privileges to Hennen's Facebook Group; however, he was rejected. **12:10 PM:** Facebook user, "Sam Wagner," requests "admin" privileges to Hennen's "Justice" page; however, he was also rejected. Dan Jr created a GoFundMe page to raise medical funds for Naila's treatment. *The goal listed was \$6,000,000.* **4:45 PM:** Dan Jr retrieves Paleo from the Palomino Pet Hospital and in a nearby parking lot, transferred the dog to the original owner to take home. Erik Nelson, the filmmaker of *A Gray State*, had interest in the case and contacted the families to see if there was interest in a documentary.

January 22nd, 2015: Youtuber, "Brendan Hunt," published a 'hit piece' video on Hennen's "Justice" page and published it to YouTube. David Kirk West published a lengthy article on why he believes the official version of the story. Tweets from Anonymous claimed the Crowley family was murdered.

January 23rd, 2015: Hennepin County Medical Examiner ruled the deaths of Komel and Raniya as homicide and David's as a suicide. Investigative Journalist, Ben Swann, interviewed DAM (video aired on 1/26/15). Komel's Funeral Service took place in Harker Heights, Texas. Wright messaged Hennen with a request to "meet tomorrow" to discuss the case. Wright contacts Greg Fernandez Jr about the case (they were previously acquainted from the group, *We Are Change in California*). **6:48 pm:** Wright messaged Hennen, "I hope you have the courage to show up for the services." **7:09 PM:** Wright and Hennen began a 35-minute phone call discussing the case. Hennen reiterated that he was not interested in granting Wright "admin" privileges to his page. **10:12 PM:** Wright messaged Hennen, "Do NOT show up for the services you disrespectful piece of shit." Wright messaged Hennen "I feel sorry for the backlash you are going to receive, but don't worry, you'll get yours." Facebook user, Kimberly Lambke, was contacted by Wright via instant message and he proceeded to bully her about the case.

January 24th, 2015: **12:09 AM:** Wright messaged Greg telling him to "stop asking questions." Theresa Shepard claimed there was "A lot of activity" in the Crowley home.

January 25th, 2015: Facebook user, "Scott Wilson," made many posts on Hennen's "Justice" page, all with the intent to distract. The *Inquisitr News* published an article titled, "*Conspiracy Theorists, Hacker Group 'Anonymous' Reportedly Blame Government for David Crowley's Death, Insist He Was Assassinated*" by Meaghan Ellis. One member on Hennen's "Justice" page researched Wilson after locating his address with the background check on Wilson showing multiple criminal charges, but strangely enough, all have "*nolle prosequi*" dispositions which mean *do not prosecute*. There are also many amended charges, dismissals, and without judgment/supervision. These are very strong indicators that Wilson may be a confidential informant.

January 26th, 2015: **6:33 AM:** Dan Feidt, author of the HongPong.com blog, published a 'hit piece' on Hennen's "Justice" page. Feidt's career doesn't add up, but he does seem to be "connected." Feidt's grandfather was a Counter-Intelligence officer in World War II. This left many wondering what Feidt actually did for a living, as he recently accepted a position in Boston, Massachusetts. **8:54 AM:** Hennen banned user, "Scott Wilson," from his "Justice" page. **9:00 AM:** Wright and various others began spamming the link to Feidt's article to dozens of members of Hennen's "Justice" page via direct messages. Hennen's immediate family began asking him, "who is Sean Wright and why is he sending direct messages to us?" **9:47 AM:** Wright messaged Hennen, "[a]re you sure you do not want to reconsider your actions?" (this was the last time Hennen corresponded with Wright.) Ben Swann interview with DAM aired: <https://www.youtube.com/watch?v=ek-3fPAwqLc>

January 27th, 2015: 1:17 PM: Lapp messaged Hagmann with his conclusion regarding the shift in the decision for *The Gray State* team not working with Lapp. Hunt messaged Wright on 1/20 and told him several lies and took other things out of context to trick Wright into thinking Lapp was some sort of fraud which is why he changed his attitude so quick. A thread on the internet forum, *God Like Productions*, mentioned a comment that David posted in the Fall of 2014 and documented that it was now removed from David's FB page. Visitation was held for David from 3:00-8:00 PM in Owatonna, MN.

January 28th, 2015: 11:00 AM: Memorial service was held for David in Owatonna, MN. A first cousin of David said that the "atmosphere was strange." David's friends acted like it was a party and a lot of laughing. This person stated that Dan Jr's behavior was "off": very high strung, couldn't stay in one spot, and very nervous. He was sure to tell close family NOT to talk to cops, media or friends. He said "something big [was] going down." Brendan Hunt published a nine-minute YouTube video as a 'hit piece' toward the Hennen "Justice" page and credited much of his information from the HongPong.com blog.

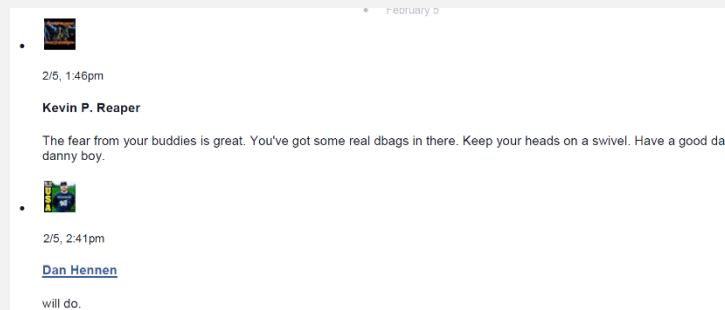
January 29th, 2015: Naila acquired medical insurance for her cancer (confirmed via an email from Dan Crowley Jr to Dan Hennen on 2/11/15).

February 2nd, 2015: 10:49 AM: Facebook user, "Eric Seyward," sent a direct message to Hennen threatening, "You say one more thing about Crowley, and I WILL pay you a visit."



February 3rd, 2015: Various Facebook posts from David's personal Facebook page are hidden or deleted from his wall.

February 5th, 2015: 1:46 PM: Hennen received a direct message from user, "Kevin P. Reaper," from Supulpa, OK that demanded Hennen "keep [his] head on a swivel."



February 9th, 2015: Sidrah reached out to Hennen on Facebook and was interested in "clearing the air" on some of the information regarding her family. Dan Jr. posted a photo of himself in front of a Las Vegas casino on Facebook.



February 12th, 2015: An unknown person filed a claim with the "Crime Victims Reparations Board" on behalf of Raniya Crowley (Claim File: #040006).

February 13th, 2015: SA Olson (MN BCA) received a CD with 20 PDF files related to the investigation from the AVPD.

February 14th, 2015: Facebook user, "Judy Prochnow," appeared on Hennen's "Justice" page claiming to be the neighbor that found the bodies. This user made over 100 posts in a span of seven hours.

February 15th, 2015: Facebook user, "Judy Prochnow," was back for several hours making lengthy posts on Hennen's "Justice" page that most people questioned if it was Judy Prochnow or a fake account. "Judy Prochnow" reported a post by Hennen to the AVPD - He said he might stop over for a "cup of coffee" as he'll "be in the area running errands". Judy responded, "you are welcome to stop by." The GoFundMe campaign is closed down by Dan Jr and it raised just over \$8,000.

February 16th, 2015: Dan Feidt was suspected of operating the fake "Judy Prochnow" Facebook account on Hennen's "Justice" page. The suspected fraud "Judy" account made a claim that they were "excited" that Sidrah wanted to meet them when she came to town. Hennen asked Sidrah about her supposed meeting with Judy to which she stated she had no idea who Judy was. The suspected fraud "Judy" was banned.

February 17th, 2015: 5:00 PM: Chris Klein called the AVPD for the first time and spoke with Det. Bone. He said he had been in the Crowley home on 1/19 and discussed the "hole in the ceiling" which was news to the AVPD. Allegedly, Lapp's "Justice" page received a direct message stating that the page was "being watched" and confirmed the killing was an "inside job."

February 18th, 2015: The AVPD received word from the MN BCA that their reports had been completed. The AVPD then called Dan Sr. to ask permission to enter the Crowley home to look at the "new-found" hole in the ceiling. **3:00 PM:** Det. Bone and McKnight entered the residence where they found the hole in the ceiling and retrieved a bullet fragment in the attic; however, they found that the attic entrance was opened as if someone had been up there recently. **4:25 PM:** a warrant was signed to search the home. **5:00 PM-7:25 PM:** a search was conducted until BCA Special Agent (SA) Chris Olson arrived. Sidrah informed Hennen that she would be taking "a break from this for a while."

February 19th, 2015: Allegedly, the AVPD reviewed photos taken at crime scene on 1/17/15 and noticed there was a hole in the ceiling near the front door.

February 24th, 2015: BCA SA Katzovitz completed the crime scene diagram of the Crowley home.

March 4th, 2015: Hennen received a text message from an unknown person who called him a "psychopathic jerk."

March 6th, 2015: Sidrah's Facebook account was hacked and inactivated for five days. Police told her they believed the culprit was a resident of Bloomington, MN.

March 12th, 2015: BCA reports and overview of the processed crime scene were added to the AVPD case file.

March 13th, 2015: Sidrah and Vinny flew from Dallas to Minneapolis.

March 14th, 2015: AVPD detectives met with Dan Sr., Dan Jr., Allison, Kate Crowley, and Sidrah

March 16th, 2015: DNA results arrived: David's DNA was on the gun and magazine and Komel's blood was on the wall.

March 22nd, 2015: Anjum and a friend drove to Minnesota with a trailer, picked up both Toyota Corollas from the Crowley driveway, and returned them to Texas. Both cars' titles were in Komel's name.

April 4th, 2015: Hendricks reached out to Dan Hennen via private message to answer some questions.

April 17th, 2015: BCA reported that the *fingerprint results were still not known.*

May 5th, 2015: DAM filed a new business called *Gray State Universe, LLC* with the Minnesota Secretary of State

May 6th, 2015: DAM applied for a Trademark for *Gray State* under the business name, *Gray State Universe, LLC*, using attorney, Gregory B. Perleberg, in Minneapolis.

May 30th, 2015: Sidrah and Vinny's original wedding date (Komel was to be Sidrah's "Matron of Honor"); however, the wedding date was postponed.

August 3rd, 2015: AT&T ran cell phone reports for Crowley family as part of the investigation.

August 5th, 2015: Latent Print Division (LPD) of the BCA reported that the palm print on the gun and fingerprint on the magazine are "not conclusive" as David Crowley. There are no matches. Exams were completed with one exception: indented writing analysis. The BCA asked if the AVPD wanted it completed, but Det. Bone declined.

August 6th, 2015: Allegedly, Kate decided to go to the Medical Examiner's office to see, in person, the Medical Examiner's report on David, Komel and Raniya and possibly to speak to Dr. Lelinski.

August 7th, 2015: Hennen called Anjum, but no one answered. For unknown reasons, this was Dr. Lelinski's last day of employment for Hennepin County Medical Examiner's Office. **Around 4:45 PM:** Anjum called Hennen and they spoke about the case for 35 minutes.

August 8th, 2015: Family, friends and boyfriend can't reach Kate.

August 9th, 2015: Kate was found dead at her home in Owatonna, MN. No reason was provided.

August 17th, 2015: Dr. Lelinski began her new job for Milwaukee County in Wisconsin as an Assistant Medical Examiner.

October 13th, 2015: The AVPD removed a review on their Facebook page created by Hennen. The review was a one out of five stars possible and fairly written. No reason was given.

November 12th, 2015: Email correspondence between *FOX 9* investigator, Tom Lyden, and Cptn. Bermel.

December 30th, 2015: Email correspondence between Lyden and Cptn. Bermel.

January 4th, 2016: 10:30 AM: Lyden met with Cptn. Bermel to review the data in the case.

January 6th, 2016: 11:09 AM: Det. Bone emailed an unknown photo to Lyden that he requested. Lyden interviewed Hendricks and Peck.

January 10th, 2016: *FOX 9 Investigators* segment aired on television and featured the "Allahu Akbar" blood smears on the wall, the Quran opened on the floor, and the message "Submit to Allah Now" quote from the notepad. This was the first time the public was made aware of this.

February 19th, 2016: A cousin of David came forward with allegations of sexual abuse of multiple young boys perpetrated by Dan Jr. while in high school at a church camp.

February 20th, 2016: Det. Bone was named AVPD's *Officer of the Year* for 2015. Det. Becker and Broughton received Department *Award of Merit* for 2015 for their work on the Crowley case. The entire Apple Valley Detective team was recognized with a Department *Award of Merit* for 2015 for their work on the Crowley case.

March 8th, 2016: Hendricks posted on social media that he was in Costa Rica.

March 14th, 2016: A screenshot surfaced that showed someone was active on David's personal Facebook Messenger account.



March 16th, 2016: Greg sent a list of 21 questions regarding the case to Det. Gummert.

March 18th, 2016: The REAL Judy Prochnow was banned from the Lapp's "Justice" Facebook page.

April 5th, 2016: Alec Wilkinson and Hendricks walk through the Crowley home.

May 10th, 2016: Det. Gummert answered Greg's 21 questions.

May 16th, 2016: Hennen met Det. Gummert at the AVPD and discussed the case. Det. Gummert explained that *FOX9 Investigators* received ALL the photos as a result of an "administrative error."

May 31st, 2016: Det. Broughton retired after 27 years of service. He was the Primary officer in the Crowley case and the officer that first noticed the rear slider was unlocked and "slightly ajar."

June 3rd, 2016: Documentary filmmaker, Erik Nelson, arrived in Twin Cities to interview subjects.

June 4th, 2016: Film crew arrived in Chaska, MN to interview Hennen. **Allegedly**, Peck was the audio tech on site. Film crew interviewed Judy and Collin Prochnow in Apple Valley, MN. Film crew interviewed Greg in California.

June 9th, 2016: Gary Swanson retired from the Minnesota BCA. He worked the Crowley case as a Senior Special Agent.

June 11th, 2016: Film crew interviewed Anjum and Sidrah in a hotel in Texas.

June 20th, 2016: Hennen received a FOIA response from the AVPD claiming "per our city attorney, we have released all that has been approved to be released for this case."

August 18th, 2016: Dan Jr. posted on the Lapp's "Justice" FB page saying, "keep up the good work, sleuths!"

February 18th, 2017: Anjum was sent a link to the "rough cut" of the documentary to view, but he didn't approve of the direction that Nelson took with the documentary and demanded that ALL of his and Sidrah's interviews be stricken from the final product.

February 23rd, 2017: The Crowley home property was purchased by Neighborhood Rehabilitation (to remodel it). It was owned by the Secretary of Veteran's Affairs.

October 26th, 2017: Dan Hennen published his audio interview with Mike Boggio III. Mike B. is the President of MEG. Mike B. confirmed they had an active deal with David.

December 18th, 2017: Wright posted a long rant on Hennen's "Justice" FB page.

January 19th, 2018: Hennen posted a photo of Paleo that was provided to him from the dog's original owner. He is clearly happy and in good spirits.

February 7th, 2018: Hennen's "Justice" FB page member, Sadey Bradham, posted the AT&T phone bills, DNA test results, autopsy results that she received via a FOIA request.

March 27th, 2018: Dan Sr. mailed the remains of Raniya Crowley to Texas.

April 3rd, 2018: Catherine interviewed Forensic Pathologist, Dr. Leon Kelly, employed by the El Paso County Coroner's office. He revealed that the bodies were only there a week.

April 5th, 2018: Hennen and Greg interviewed a professional Behaviorist named Russell on YouTube.

April 20th, 2018: Medium from Texas provided details on the case.
