She said, um, I won't say that the group hasn't caused me grief cuz it has, I have obsessed over it for a good six months when it was first created only because there was so, so, so much this information and people were talking about my family, but I've finally given up on trying to convince them to go away or tell them what I know. I am not against it because I get that the people on the group have grown attached over this case throughout the years.

And to some it's their personal experiences that have been similar and they weren't able to do anything for themselves or that person. And that's what has brought them to the group, um, to the group, no, brought them there to get some sort of closure for themselves. So this may be therapeutic to them. So who am I to tell those people to go away, but I'll tell you what I am against. There's two sides to this tragedy facts and personal evidences. I don't think personal evidences have anything to do with the group, like talking about the families and even talking about David and Kimmel's journals. That's something for the family to know. Um, y'all need to focus on the crime scene and just focus on the facts from the day. This occurred nothing more than that should be discussed because it's not anyone's business. When the police investigated, they didn't care where my dad worked decades ago, or if Dan junior was gay, they looked at facts from that day. And that's what y'all need to do. Just sitting there having conversation. Isn't going to get you anywhere. Schedule a meeting with investigators, sit down with them and get, get y'all's list of questions about the facts and get those answers from them. If they are not willing to sit down with you, I can try to see if they would be willing to meet up with y'all or would be willing to answer some questions over a call. I'm sure that I can MI to do that.

I mean I see her point of view, you know, I get the weird thing about me is I get to see both sides. I agree with you guys at certain aspects. And I agree with CI, you know, um, as far as journals go, I think that should be released, but that's just me, you know? Um, the reason why I say that is the journals have a lot of information, you know, um, Davids were a little weird, you know, he was, he wasn't the easiest person to read, but um, you know, as far as Kimmel's go, you know, sh that's all she spoke about. So I think like maybe in time Sidra would be willing to, you know, release some of the journals, but it really shows you what Cammel was going through. And I don't think she even understood what she was going through. So, um, I, yeah, I mean, it started in July when, um, Nyla got sick and um, you know, she started writing just, I guess, her thoughts and stuff.

And um, she talks about her, her dad and how frustrated she was with him and just, you know, back and forth with the family. Um, she was just trying to understand her feelings and I think she was just very confused because she wanted to be there for her family. But I, I don't know why she didn't say that on her journals, but David didn't want that. She didn't want her coming down here. And that was, you know, that was the plan. Um, even after she disagreed with MRAM about, you know, doing chemotherapy and stuff, um, she was supposed to come down here, um, for, um, Nyla surgery. Um, you know, Mr. Olan was gonna buy her a ticket and you know, even though there, they didn't agree on things, they were still, you know, she was still there for them. And then one of the journals that stuck out to me was overnight, she sat down with David and he convinced her that, um, she shouldn't, she shouldn't come here. Um, that's not her family anymore. Ronnie and David are her priority and, you know, let them figure it out. Um, and you can, it is just a pattern. Like it's very interesting, you know, reading them and seeing how it, it shifts when and how her, um, even her own emotions change. You know, she starts doubting herself, you know, she starts off strong and, um, you can see, um, you can see a pattern. So, um, yeah, I don't, I don't know exactly what else you wanted me to cover on, on her journals.

Um, well, I think there's, there's a lot, I mean, any, anything that would help us understand what they read in those journals that made them think that David Crowley was guilty would definitely be, be good now I, I mean, just to be, be before we get there, I just wanna, you know, people should really recognize that that's a big deal if, um, Kimmel's mom, you know, is going through all of this pain, all of this suffering, um, why wouldn't David want Cammel to go see her mom? It

Was about, it was more about control for him. Um, I think ever since that time, when Kimel called her dad and said she was leaving him, I think ever since then it was very, um, you know, it was very, I guess he was scared for that. He, he didn't really like, um, for Kimel to come down here. I mean, um, I don't know if you guys know this, but she's only came down to Texas twice. Um, and she, it was the two times that she got the cars and one of those was Sid's graduation, but any other events, she never came down to Texas. Um, Sidra was the one that would go in the summer and, you know, spend Christmas 'em because she just couldn't come down here. And I think that speaks like a lot too, because it just shows, you know, I mean, what daughter wouldn't wanna visit their, you know, her family and her friends in, in Texas.

And I think that speaks a lot from his side on how controlling he was on that aspect. I mean, everybody, uh, I mean, you know, I'm, I can, you know, every man is different and to a certain extent, you know, there is some control there and that's totally fine. You know, everybody, everybody has that in their relationship, but, you know, to a point where, you know, you can't do certain things, he's making her quit her job. And he even writes that on, in his journal on how he planned it. And he was surprised that he was able to convince her. So, I mean, um, it

just shows manipulation, you know, it just shows like how possessive he was over her and, you know, um, the night of her, of their, um, of David's, uh, reunion, you know, um, he writes about that, how, you know, one of his, um, old buddies from school, you know, complimented Cammel and, and, you know, called her beautiful and whatever.

And, you know, he didn't like that. And he just writes a whole article, which was so crazy and it shows his possessiveness. He says, she's mine. And, um, I married her because of her beauty and just, it's bizarre, you know? Um, I don't have to journal with me right now so I could read it. But, um, it just, he was very possessive, even Ronnie, you know, was he writes about her, how he came in between, um, their marriage and, you know, as a, as a parent, I would never think my daughter would come in between me and my husband, you know? Uh, um, so I mean, it just shows how possessive he was over Cammel. Um, so I think that's part of the reason why, you know, she wasn't able to come down here. He was scared. He didn't want her, you know, coming down here and maybe, you know, changing her mind and wanting to stay here in Texas. I don't know what was going through his mind, but I think that had a lot to do with it.

So when you say his journal, cuz we've heard from different people, multiple sources, blah, blah, blah, about different journals. When you say that he wrote this in his journal, can you, can you clarify which journal you're you're talking about? Because I've heard about several journals.

So the only journals I've seen is a written journal that he had, he had three journals. He only wrote in one, one of 'em had one page on it that apparently he was gonna, you know, keep up with, but he never did. But the one I'm speaking of was the, was a DK and a heart on it. That was the first, the, like the front page of it. So I'm guessing that was David and Cammel. And um,

So these are, it was a written journal.

Okay. Yeah. Cuz, cuz we've heard about a written journal, a video journal and then guess I don't there's

Any truth there's no, I don't think there's any truth on the video journals. Um, that is something I asked to about it. And she said that, um, it was said that there was an online journal, but she

hadn't seen anything from the online journal. It was just, um, just a written one that she knew of. And that's something we both have read.

Well that, that online journal is in the police reports. So it's a journal called, uh, something he was writing in day one and I believe it ended in November of, uh, 2014. And I think it only started, uh, maybe that, that, that previous summer. So it wasn't a very long video journal, but I think, and then you can see in the documentary, um, they, you know, some of that stuff, they call video journal. So it's like, okay, well what is, what, what do they really mean? Because those are those videos that David made.

Yeah. Um, I feel like a lot of it also has like misinformation also has a lot to do with, um, the police not doing the best job possible. And I think honestly, um, they, they just had, they told, uh, Sidra this too. It, when she went in March that, you know, they have never dealt with something like this. They really had to, you know, figure out how to do it. Like some something she had mentioned was that they had to call the Bloomington, um, police and, you know, contact them. And you know, a lot of times they, they were confused or didn't know what to do. They would contact the higher ups and ask them for advice. So I think, you know, um, I feel like they should have just hired a totally different company or I don't know how it goes honestly, but they should have had someone higher up who had an experience on this, do this and not them. So I, I see as a third person, why you guys are frustrated cuz of all the misinformation from the police reports. Um, so yeah, I, I see, I see like that, that aspect of it.

Like she was living two different lives. She was agreeing with David just to keep the peace in the house, but the way she truly felt she was right down on her journals. And there were a lot of different instances where she also spoke about being scared of him. Um, she wrote one time that she took Ronnie out to, um, she just left the house cuz she was so scared of David because, um, I, I think that was the time when he, um, tried trims and um, he was hallucinating and he, what else did she say? She said, um, I, mm, I wish I had the journals on me, but she basically just, just talks about how scared she is. And that's not something that Ronnie should be around and apparently she didn't even know he was gonna do, which, um, she was really angry about they hadn't, um, that caused a really big rift between the relationship because that's not something that come out wanted Ronnie to see, you know,

Was, was David doing this by himself? Or was he with friends?

No, this was by himself. And she, um, she wrote that she, she locked him in the room. I don't know which room she locked him in, how she did that. But she said that she was scared for him and she didn't know how to handle it. And um, she also wrote that she thought about calling his dad, but, um, and she also wrote that, um, he has alienated everybody and I don't even know who to reach out to anymore. And you know, just certain things she says, it just shows how, how alone she felt and you know, it shows, um, it shows that she didn't agree to it. You know, most of the things that were going on, it's just, you know, it's just beyond me that she was such a strong, independent girl and she didn't think she, like, I just don't know why she just didn't leave, you know? Um, if she felt that way, you know?

Yeah. I can. I mean, I, I can re relate to a that cuz my, yeah, I've, I've dealt with a similar thing in you. You do kind of, kind of wonder that, like why don't they just leave? But obviously

I trust. Yeah. Right. And that was something that was part of the reason why she was writing in her journal because she was so that he would do that to her. You know, he would put her, put her in that position where she wasn't even aware of this, you know? So that was part of the reason why she even wrote it in her journal. And, um, he did mention in his journal about asking Danny Mason about Shri, cuz apparently he had done them before. And um, Sidra had asked Danny Mason at it and he said that, um, David had asked him about his experience and Danny told him, I don't think you should go that route. I didn't have a good experience with it. Um, um, and honestly he also said that I was, did she say she, he said, he said that, um, once you get that high, you always want something, you know, more like something more, that'll give you that high. So that's not the route he should go. And, um, Danny told her that, um, David said that he, he was just tired. He wanted something more, you know, he wanted to feel something more so, um, but SI asked him if, if he was the one who had given him the rooms and he said he had no idea about it. So I don't know if it was Chris Peck or who it was, who gave him that.

brought up and I was there too. Um, it was a very weird lunch. That is where I saw the disconnect from Cammel.

Um, I don't think Sidra had noticed that I even brought it up to Sidra and I said, Camilla's pretty different. Um, she's talking a lot more like David, you know, and she's like, well, you know, you're, they're married, you live with somebody, you start talking a like that. And I was like, yeah, but you know, any little thing we talk about, she always looks at David, like, is it okay? You know? Um, I think I had mentioned that, um, I had arranged a little get together for the girls in 2000, her last visit in may. Um, I asked if she could come spend the night, you know, just us girls have movie night and stuff. And her first instinct was to look at David and

See if it was okay with him, which I don't see why it wouldn't be, you know? Um, she was only down here for like, not even three, four days. So, um, yeah, it, it is just like different things like anything she said or anything, things that was talked about that she would always look at him for his reaction, if is he okay? Like even with sitting with MRAM, you know, MRAM, I don't know if you, if you know, he's very, um, he's a character, he's a very good person and, you know, he'll, he'll speak his mind. So just like having him around David, like her anxiety level was so high because she had to, she was, she was holding David's hand, you know, and she would just always look at him every time Mr. Long

would talk, like to make sure is he okay? You, you know, I just, it just didn't make sense. It was just a really awkward place to be in for myself.

Sure. Hmm. So, um, can I ask you, what note did I have here? When did you meet Cammel?

Natasha: ([00:26:31](#)):

I met Cammel, um, I'm at Sidra first because, um, we both went to middle school together. Um, my dad, he is Italian and my mom is Pakistani. So that's how, uh, we had something in similar, you know, when she moved down here, um, she didn't speak English at all and she had no friends and, you know, I could relate to that. So we became friends really, really quick. And, um, both of our moms, you know, um, we, you know, they got together and it just, you know, we just had a lot of things SIM like in similar and, um, It, it grew pretty, pretty fast. And, um, I met Cammel, I would say when I was 13. Yeah, 13, 14. So it's, it's been a while. Um, our families are really close. Uh, we, we both lean on each other and, um, the long side of the family has helped me a lot. We used to live in Dallas and I actually moved down to Waco with them. Um, that's where I met my husband too. And yeah, so like the along side of the family is, is a, is a pretty big chunk of my family too. Um, I don't have any family here in Waco. Um, they're all I have. Um,

But, but yeah, Camal was a pretty big part of my life told she was here in Texas. I saw her every day. Um, so that's why I saw a disconnect when she came back from Minnesota, her last visit because she wasn't herself

The only reason they came down was because apparently his mom couldn't take care of Ronnie. So they needed someone to take care of her for, you know, for a little while, while they were there. So they dropped Ronnie off. And, you know, since, uh, Nyla always talks about wanting and Ronnie, cause she left Ronnie for two months back in the day too. So, uh, I guess they could trust her. So yeah, they, they came down for a couple days left Ronnie, and then they went, um, they went to California and then they came and picked her up and they got the car and went back to Minnesota.

And, uh, that just wasn't it. Um, Dan sand here never wanted to talk, you know, just, it would be through email or a text message and a day late or a week late conversation. So yeah, it, they're, they're a hard family to, to communicate with and that's something even his friends say, you know, it's just, that's just how they are. That they're a little weird, I guess. I don't know.
